- **Turn Signals and Brake Lights:** Install turn signals and brake lights that have received DOT approval for safety and visibility.

- **Mirrors:** You must have a minimum of one rearview mirror.
- **Horn:** It is necessary to have a working horn.
- **Tires:** For use on public roads, the tires on your dirt bike must have DOT approval.

Riding your dirt bike on a public street without these modifications is a prohibition and may result in fines or other legal repercussions.
